Pursuant to the approval of the Board of Directors at its meeting held on November 08, 2023 and approval of the members of the Company at their Annual General Meeting held on Thursday, September 28, 2023 and pursuant to In-principle approvals granted by BSE Limited vide their respective letter dated October 26, 2023 and upon receipt of an amount aggregating to Rs. 3,75,00,000 (Rupees Three Crore Seventy-Five Lakh only) at the rate of Rs. 2.5/- per warrant (being 25% of the issue price per warrant) as warrant subscription price, the Board of Directors of the Company, has considered and approved the allotment of 1,50,00,000 (One Crore Fifty Lakh Only) warrants on preferential basis at an issue price [including the warrant subscription price (Rs. 2.5 per warrant) and the warrant exercise price (Rs. 7.5 per warrant)] of Rs. 10/- each (Rupees Ten only) aggregating to Rs. 15,00,000/- (Rupees Fifteen Crore Only) to person belonging to other non-promoter persons/ entities ('Allottees') (as per the list enclosed marked as **Annexure I**).

Each of the Warrant, so allotted, is convertible into or exchangeable for one fully paid-up equity share of face value of Re. 1/- (Rupee One only) of the Company in accordance with the provisions of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, on payment of the balance consideration of Rs. 7.5/- per warrant (being 75% of the issue price per warrant) from the Allottees at the time of allotment of equity shares pursuant to exercise of conversion option against each such warrant.

The meeting of the Board commenced at 10.00 A.M. and concluded at 10.30 A.M.
